Plan Statement

BizFlex plan is **for business customers under KEPCO 'Plan A', less than 6 kVA**

This price plan is comprised of Monthly Base Charge, kWh Charges (3 tiers listed below) and the Energy Cost Adjustment:

- Tier 1: 16 - 120 kWh
- Tier 2: 121 - 300 kWh
- Tier 3: 301 kWh or more

T'dash rate plan is not directly linked to the market price.

This plan is eligible for the Introductory Price Plan.

We will continue to offer good value prices after the 6 months Introductory Price Plan period has ended.

Please note this introductory price plan applicability is contingent upon paying all invoices by their due date. In the event that payment is not received by an invoice's due date, customers will be moved to T'dash's prevailing rate effective as of the day following the past-due invoice's meter read date.

Additional Documents and Information

You can confirm your usage and billing on the website. If you choose a paper billing option for each account, it will be charged at 110 yen for each account. Payment will be accepted by Bank Account Transfer, Credit Card (including Debit Card) and Konbini payment* (issuance fee for Konbini payment slip is 220 yen per month for each account).

*Before you can use Konbini store payment slip as a payment method, we require you to register your credit card information. In the event that payment cannot be confirmed by the due date, we may charge the unpaid balance to the registered credit card.

Your total charges will include Monthly Base Charge, kWh Charges, Energy Cost Adjustment, Renewable Energy Charge and other pertinent charges. Please note that total charges include sales tax.

Energy Cost Adjustment (ECA)

The Energy Cost Adjustment (ECA) is generally the same rate as or similar rate to, subject to market conditions, the EPCO Fuel Cost Adjustment (FCA). The FCA calculation can be found at the Kansai Electric Power Co, Inc. primary website.

Renewable Energy Charge (REC)

The Renewable Energy Charge is the same rate as what would be charged by your default EPCO. The REC calculation can be found [here](#).
